

# Building Excellence Research & Education Grants

### **When was this grants program launched?**

BC Housing launched the Building Excellence Research and Education Grants program in January 2015.

### **What is the purpose of the grants program?**

The grants program is designed to encourage externally generated research and education to improve the quality of residential construction and enhance consumer protection for buyers of new homes in British Columbia. Industry and consumer organizations, education providers and independent researchers can identify projects and apply for funding.

Sharing information, fostering excellence and advancing best practices help us deliver our ongoing mandate: strengthening consumer protection for home buyers and improving residential construction.

### **Who is eligible to apply?**

Organizations or persons resident in Canada, including:

- Industry organizations
- Consumer organizations
- Education providers
- Housing Sector Organizations or Associations
- Independent researchers including college and university researchers

### **How many times per year will grant applications be accepted?**

Submissions are accepted once a year, based on available funding. A summary of previous grant recipients is available online at [www.bchousing.org](http://www.bchousing.org).

### **What are the key application dates for 2020?**

The 2021 application intake period opens November 2020. Submit your completed application to BC Housing no later than **Friday, January 29 at 4:00 pm**.

### **When will I be informed if my project received funding?**

All applicants will be notified by email on the outcome of their submission in April 2021.

## How much funding is available?

The number of grants awarded each year depends on available funding and the number of applications received. Eligible projects may receive up to a maximum of \$30,000. Preference may be given to projects that leverage partnerships and funding from other sources.

## What types of projects are eligible for funding?

Projects must align with BC Housing's mandate under the Homeowner Protection Act to enhance protection for buyers of new homes and improve the quality of residential construction in British Columbia. The final results must be relevant to the home building industry, Licensed Residential Builders and Building Envelope Renovators or homebuyers in B.C.

The types of projects that are eligible fall within four categories: industry research, industry education, consumer research and consumer education.

The following topics are intended as helpful suggestions only. Other topics or innovative projects proposed by applicants are encouraged and will be considered.

### Industry Research and Education Topics

- BC Building Code requirements and standards
- Business planning and management
- Construction technology
- Construction management and supervision
- Customer service and home warranty insurance
- Energy efficiency and sustainability
- Epidemic-related construction and design practices
- Financial planning and management
- Homeowner Protection Act and regulations
- Housing market studies
- Legal issues in residential construction
- Residential construction practices
- Other topics of interest and innovative projects proposed by applicants

### Consumer Research and Education Topics

- Consumer protection education and information resources for stakeholders involved in buying and selling homes (e.g. real estate licensees, lawyers, notaries, lending institutions)
- Education and information resources for homeowners/homebuyers related to:
  - Consumer protection, particularly home buying and home warranty insurance
  - New home and maintenance and governance
- Homeownership and housing market trends
- Other topics of interest and innovative projects proposed by applicants

### **Is research conducted outside the province of British Columbia eligible for funding?**

While project results must benefit the residential construction industry and home buyers in B.C., the development and execution of the project can occur outside of British Columbia.

### **Can I apply for funding for more than one project?**

Yes, you can apply for funding for more than one project at a time. However, only one grant will be awarded per organization in each funding application period. Eligible projects may receive up to a maximum of \$30,000.

### **If I am a successful grant recipient, can I apply for additional funding in future application rounds?**

Yes, applicants who receive a Building Excellence Research & Education Grant may submit a new request for funding in future application periods. These applications must be for new projects that have not previously been granted funding. Multiple grants are not provided for different phases of the same project. To ensure a fair process, please note we are unable to provide information on the anticipated success of your application.
