

SUPPORTIVE HOUSING IN VANCOUVER

BC Housing and the City of Vancouver are taking collective action to address the critical needs of people experiencing or at risk of homelessness in Vancouver.



New warm, safe homes with supports on Renfrew Street at East 14th Avenue



Vancouver is in a housing crisis and more than 2,000 people across the city are experiencing homelessness. Creating warm, safe homes with supports for people experiencing or at risk of homelessness in our communities continues to be a top priority for BC Housing and the City of Vancouver.

BC Housing and the City of Vancouver are proposing to build a six-storey building with approximately 50 new homes with supports at 2930 Renfrew Street. The homes would be for adults, seniors, and people with disabilities who are experiencing, or are at risk of, homelessness with a priority for people in the local community.

- All units would be studio apartments with a private bathroom and kitchen
- At least 5% of the homes would be fully accessible
- The building would also include amenities such as shared laundry, a dining area, program space, and an underground parkade

Moving forward at 2930 Renfrew Street



Dates in the timeline are approximate and subject to change.

BC Housing and the City are committed to moving forward with a rezoning application to develop this specific site.

Through the City of Vancouver's development process, we invite community feedback on aspects of the development proposal, including:

- Building and site design elements, such as lighting and landscaping
- Local representation for the Community Advisory Committee (CAC)
- Ideas for how to support the success of the proposed building
